

# Individual Professional Investor Assessment Form

**(C) Right to Withdraw From Being Treated as a Professional Investor 撤回被視為專業投資者的權利**

I/We understand that I/we have the right, at any time, in respect of all investment products and/or markets or any part thereof on giving a written notice of not less than fourteen (14) business days to GHIS to cease and withdraw from being treated as a Professional Investor. I/We acknowledge that GHIS is entitled to treat me/us as a Professional Investor unless and until receives in written of my/our request to cease and withdraw from being treated as a Professional Investor.

本人/吾等明白本人/吾等有權在任何時候，就所有或任何部份產品及/或市場以不少於十四個工作天的書面形式，通知露海國際證券撤銷作為專業投資者身份。除非本人/吾等於不少於十四個工作天前以書面形式向露海國際證券取消作為專業投資者，否則露海國際證券則繼續視本人/吾等為專業投資者。

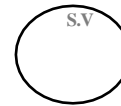
